10. Entries must be received during the Promotional period. No responsibility accepted for late, lost or misdirected entries. Incomplete or indecipherable entries will be deemed invalid.

12. There will be one (1) prize and one (1) prize winner. The winner will receive a dinner party for themselves and seven friends at the winner's home. This will include a four-course meal prepared and served by Chef Daniel Wilson and his Sous Chef, paired with matching wines from Swords Wines in the Dairy Produce Hall. The winner will have the opportunity to shop with Chef Daniel Wilson at Queen Victoria Market the day(s) before the dinner party for the desired, seasonal ingredients at a mutually agreed time. As part of the prize, all main cooking dishes/utensils will be cleaned by the Sous Chef. Dietary requirements will be catered for during the Market shop.
13. The dinner party is to be held on a mutually agreed date and time by the winner and Chef Daniel Wilson and will be held between September – November 2019.
14. The proposed kitchen must be in good working order to cater for group of eight.
15. The winner will be drawn randomly from the valid entries at the Queen Victoria Market head office, Level 8, 365 Queen Street, Melbourne.
